EXPANDED ITS COUNSELING PROGRAM WITH THE ADDITION OF THE CLIENTS, STAFF, AND INFRASTRUCTURE OF EQUINE CONNECTION COUNSELING, PLLC. AS A RESULT, STEPS GROWTH IN 2022 WAS DRAMATIC. S.T.E.P.S. WENT FROM A BUDGET OF \$70,000 IN 2021 TO A BUDGET OF OVER \$250,000 IN 2022. THIS EXPANSION COUPLED WITH AN INCREASE IN THE FINANCIAL CONTRIBUTIONS BY OUR DONORS AND GRANTORS IN 2022, ALLOWED US TO SIGNIFICANTLY EXTEND OUR REACH. THE NUMBER OF COUNSELING SESSIONS WE WERE ABLE TO FINANCIALLY SUPPORT THROUGH GRANTS AND HARSHIP SCHOLARSHIPS INCREASED BY 38%.
